Sub: Remittance of Non-Tax Receipts through NTRP (Bharatkosh) to URSC - reg.

The Non-Tax Receipt Portal (Bharatkosh) is the initiative of O/o Controller General of Accounts, M/o Finance, Government of India to provide one stop services to deposit any fees/fine/other receipts into the Government Account. It converges all the Civil Ministries/Departments of Government of India. It aims to provide 24X7 electronic services to deposit the money into Government Account using internet based payment technologies to the users at the door step through the web based portal. Accordingly, the roll out of Non-Tax Receipt Portal (Bharatkosh) for remittance of Non-Tax Receipts to URSC is being implemented w.e.f 26.02.2024.

In pursuance of the mandate, Serving/Retired employees, Suppliers/Service Providers, Apprentices, Contract staff and other Stakeholders are hereby directed to remit the Non-Tax Receipts through NTRP (Bharatkosh) only. A detailed SOP (Annexure-I) and list of Purposes (Annexure-II) in respect of F&A(C) and SOP (Annexure-III) and list of Purposes (Annexure-IV) in respect of F&A(P) are enclosed for reference and compliance.

In this regard, all the stake holders may kindly take note of the instructions and make use of NTRP portal to actively promote and encourage digital transactions as part of Digital India initiative.
